### **GUIDELINES**

Nominations may be made by anyone. Those wishing to nominate themselves may do so.

The nominee for 2017 Tasmanian Transport Industry Diversity Award must be:

 An individual or a business active in any sector of the Tasmanian Transport Industry

Nominees must be able to demonstrate that their workforce diversity initiatives, programs or actions feature:

- Engagement with and support from staff of the organisation and key stakeholders
- Innovation in practices to address issues impacting on the attraction, recruitment, retention and development of a diverse workforce
- Sustainability of the program or initiative longer term including senior leadership commitment within the organisation and impact on organisational culture
- Capacity for the initiative to be repeated or transferred

Nominations must have the following attached:

 a good quality, electronic photograph that can be used for publicity purposes.

Judging of the awards is conducted at the discretion of the TTA and by the Award Sponsor, TasRail. The decision of the judges is final and no correspondence will be entered into. The 2017 Award Winner will be announced and presented with the Award at the

Tasmanian Transport Association Gala Dinner & Awards, Saturday 21 October, 2017, Wrest Point, Hobart.
